<p>Description</p>	<p>The Extension Educator-Conservation Agronomist position is a collaborative effort between the University of Minnesota Extension Service, Rural Advantage and GBERBA. The Conservation Agronomist position provides educational programming focused toward third crop rotations, cover crops, sustainable agriculture, perennial bioenergy crops, soil health, crop nutrients, crop rotations, cover crops, carbon sequestration and practices that provide ecological uplift. This position works across southern MN with at least 75% of their effort dedicated to the Blue Earth, Le Sueur and Watonwan River Watersheds.</p> <p>This position will help promote all local programs for Counties and SWCDs, helping engage our local citizens through the MN Extension Service and leverages \$5,460.00 through the McKnight Foundation and \$5,460.00 from the Specialty Crop Grant. Numerous news releases, TV promotions, group presentations, displays and field days/tours will be created and presented to watershed residents. Description

The Cobb Watershed Technician assists the landowners of the 114,735 acre watershed and provides them with guidance on projects and programs to help improve water quality. The position also provides technical support in designing, surveying, staking and construction inspections of projects for the SWCDs and the SC-TSA, with the SC-TSA providing guidance to the Technician when implementing BMPs.

The Technician has a goal of working on and completing the following BMPs in the Cobb Watershed during the 2012-2014 grant period:

Waterways (3); Streambank Stabilization (1); Grade Stabilization (2); Shelterbelts (3) and Side Inlets (1) and also goals working for the Greater Blue Earth River Basin:

Grade Stabilization (3); Wetland Water Control Structure (1); Streambank Stabilization (1); Ravine Stabilization (1) and Shelterbelts (3).

Technical Authority is approved by the qualifying SC TSA or Blue Earth SWCD staff when necessary and applicable.

JULY-DECEMBER 2012:

During 2012 GBERBA requested the change of position title and description for the Nutrient Mgmt Specialist to Watonwan Watershed Technician. Reasons: The position has been in existence since June 2007, and we are now working to fill the position for the third time with limited success. Because this position is very specific in scope (nutrient mgmt) we are not receiving a full panel of qualified applicants, thus our request to broaden the scope of the position to a watershed technician. This position will still access training to offer nutrient management planning throughout the basin, but also train in a wider range of technical capabilities as needed in the watershed. Training would include state and federal conservation practices, buffer and long term conservation programs and any other program as deemed necessary in the watershed.

This change will also come at a time when MPCA is expanding into the Watonwan for their Intensive Watershed Monitoring strategy starting in 2012, and will lead to accelerated implementation under the Watonwan River Watershed TMDL project. This position will be housed in the Cottonwood SWCD Office (contract with GBERBA until June 30, 2013 will be amended) but work throughout the Watonwan River Watershed, and throughout GBERBA on nutrient management planning.

Work throughout the summer and fall consisted of developing a new position description and job announcement and start the interview process.

This process was starting May 2012 with an official request extending the grant to December 31, 2013 and changing the position focus to a watershed technician. Approval for the grant extension have been executed. The position change has been approved by email from Chris Hughes indicating a workplan revision through the affected grant agreements.
